SPECIAL ELECTION TO AUTHORIZE RENEWAL OF ADDITIONAL LEVIES
Board of Education of the County of Marion
November 6, 2018

Special election to authorize renewal of additional levies for the fiscal years beginning July 1, 2019, July 1, 2020, July 1, 2021, July 1, 2022 and July 1, 2023, and for the purpose listed according to the Order of the Board of Education entered on the 16th day of July, 2018.

- To continue to provide for free textbooks, Subject Matter materials, media materials, teaching equipment and instructional supplies at an annual approximate amount of\$1,902,673.00
- To maintain salaries of professional Personnel, dental/optical insurance, and other benefits at an annual approximate amount of\$6,476,101.00
- To provide for continuous maintenance of buildings and upgrading of transportation fleet at an annual approximate amount of\$2,743,785.00
- To maintain salaries of service personnel, dental/optical insurance and other benefits, at an annual approximate amount of\$4,118,369.00
- To provide technology, capital and infrastructure Upgrades at an annual approximate amount of\$2,200,000.00

The renewal additional levy, per One Hundred Dollar assessed valuation, shall be as follows:

- Class I (Tangible Personal Property) 22.95c
- Class II (Owner Occupied Homes and Farms) 45.90c
- Class III & IV (Commercial and Industrial Property) 91.80c

MARION COUNTY COMMISSION SPECIAL ELECTION TO AUTHORIZE ADDITIONAL LEVY

A special election to authorize additional levy for the fiscal years beginning July 1, 2019, July 1, 2020, July 1, 2021 and July 1, 2022 for the Marion County Volunteer Fire Departments, in the amount of \$780,000.00 annually and \$3,120,000.00 the term of the levy according to the Order of the Marion County Commission entered the 8th day of August, 2018.

That the additional rate of the levy in cents per hundred dollars of assessed valuation on each class of property shall be:

- Class I 0.93 cents
- Class II 1.86 cents
- Class III 3.72 cents
- Class IV 3.72 cents

In the event the separate and aggregate assessed value of each class of taxable property within the County increase during the term of the special excess levy, the levy shall be reduced so that the projected tax collection will not exceed \$780,000.00 in any fiscal year.
